"170.SICK"— LIFE AT THE INTERSECTION OF CCP § 170.6 AND RULES OF PROFESSIONAL CONDUCT RULE 8.3

OVERVIEW

I. Topic: Intersection between 170.6 removal for cause and Cal Rule Prof Responsibility 8.3, also known as the 'Snitch Rule.'

Cal. Rules of Prof'l Conduct 8.3(a)

A lawyer shall, without undue delay, inform the State Bar, or a tribunal* with jurisdiction to investigate or act upon such misconduct, when the lawyer knows* of credible evidence that another lawyer has committed a criminal act or has engaged in conduct involving dishonesty, fraud,* deceit, or reckless or intentional misrepresentation or misappropriation of funds or property that raises a substantial* question as to that lawyer's honesty, trustworthiness, or fitness as a lawyer in other respects.

Cal. Code Civ. Proc. § 170.6

A judge, court commissioner, or referee of a superior court of the State of California shall not try a civil or criminal action or special proceeding of any kind or character nor hear any matter therein that involves a contested issue of law or fact when it is established as provided in this section that the judge or court commissioner is prejudiced against a party or attorney or the interest of a party or attorney appearing in the action or proceeding.
